### **Survey Methodology**



TargetSmart designed and administered this online survey. One hundred ninety-eight interviews (103 weighted) were conducted online among panelists who were matched to the TargetSmart voter file, and 653 interviews (497 weighted) were conducted online using text-to-web and email-to-web (219 email, 434 SMS) solicits from the TargetSmart voter file. In total, the survey reached 851 adults (600 weighted), age 18 or older, who are registered to vote in Arizona.


Quotas were designed to reflect the demographic and geographic distribution of registered voters in Arizona. The data were weighted by gender, age, race from file, party registration, TargetSmart Midterm General Election Turnout Score, TargetSmart High School Only Score, region by county and senate district, and 2020 presidential election vote to ensure an accurate reflection of the population.

The credibility interval (the theoretical margin of error for a blended-methodology poll that relies partially on telephone-based probability sampling, and partially on non-probability based online panel sampling) is +/-4.0%. The margin of error for subgroups is larger and varies. Percentage totals may not add up precisely due to rounding.

Direction of Arizona - Time Series



































#### Paid Family and Medical Leave Covering All Workers







#### Minimum Wage for Construction Workers



















Importance of Access to Parks to Arizonans' Health During COVID-19







#### Investing in Parks Helps Rebuild AZ Economy








Q.42 Do you support or oppose ending the use of mandatory minimum sentences for non-violent drug crimes in Arizona?

#### **Expunge Records for Marijuana-Related Offenses**



#### Law Enforcement Officer Misconduct Database




Q.45 Do you support or oppose creating a database that would track and make public instances of discipline and misconduct for law enforcement officers in Arizona?
