Survey Methodology



TargetSmart designed and administered this multi-modal survey. The survey was conducted **November 30-December 9, 2021**, via live phones with trained operators, online via a link from an email, and through Dynata's web panel and matched back to the voter file. The survey reached **1,238 adults (750 weighted)**, age 18 or older, who indicated they were registered to vote in Florida.

The sample was randomly selected from TargetSmart's enhanced voter file. Ten percent of respondents were reached on telephones (19 percent weighted). Twenty-six percent were reached via email and took the survey online (55 percent weighted). Sixty-four percent of respondents were recruited from Dynata's web panel and matched to TargetSmart's voter file (24 percent weighted). Quotas were assigned to reflect the demographic distribution of registered voters in Florida.

The data were weighted by gender, age, race on file, party registration, TargetSmart High School Only Score, TargetSmart Midterm General Election Turnout Score, and region by media market to ensure an accurate reflection of the population

The overall margin of error is +/- 3.6%. The margin of error for subgroups is larger and varies. Percentage totals may not add up precisely due to rounding.




Key Findings

- Florida voters support increased taxes on the wealthiest individuals and corporations and oppose tax increases on low to middle-income families and small businesses.
- Respondents across demographics and ideology report high levels of concern about the COVID-19 pandemic.
- Three common progressive proposals to improve voting access receive majority support, with 7-in-10 respondents referring to early voting access as a good thing.












Respondents view more investment as a better response to COVID-19 than cutting resources














Proponents of this new law say that it limits the potential for voter fraud and related abuses.

Felony Ballot Collection Support by Party ID and Urbanicity








Floridians split on whether fraud or voting obstacles are a bigger concern


