About the Survey

- Total N=500 Latino registered voters (+/- 4.4%)
- Field Dates: January 31– February 13, 2025
- Survey available in English and Spanish, according to respondent preference
- Mixed mode with live telephone, text invites, and online self-complete
- Final sample weighted to match demographics of NV Latino electorate

Political Landscape: 2024 into 2025


What we learned on election day in 2024

1 in 3 Latino voters in Nevada were first-time presidential voters

While Latinos tend to trust Democrats more than Republicans, 1 in 3 voters believed that neither party cared much about issues important to the Latino community

It's clear that Democratic vote share was down in Nevada 2024, however Latino voters continue to show support for a progressive policy agenda

Top-of-mind issues for Latino voters are dominated by economic concerns relating to inflation, cost of living, cost of housing, health care costs...




Key Findings: Nevada Latinos 2025

- 1. In 2025, top issues continue to be driven mostly by economic concerns:
 - Cost of living, housing affordability, and health care costs
- 2. On housing policy: specific proposals with direct language and actionable steps perform better than generic promises
 - > Rent control for seniors, homeless shelters, eviction protection, and first-time home-buyer assistance
- 3. Nevada Latino voters **do not** support current nation immigration actions nearly half personally know someone who is an undocumented immigrant.
 - Support for immigrant protections remains consistent across all segments. Policy measures that specifically include immigration protections in the workplace received especially high importance ratings.
- 4. Healthcare: In light of proposed cuts to Medicaid and Medicare, lowering prescription drug prices for Nevada ranked highest in intensity above 70% *very important* across nearly ALL segments.
- 5. 54% of Latino voters in Nevada report speaking Spanish at home with family or friends daily.
 - > Naturalized voters are very supportive of the state government taking action to improve language access.
 - Younger voters (ages 18-29) are more likely to consider language access policy ideas as important, along with voters in bilingual households many of whom live in multi-generational households and often do language interpretation for family members.






Housing costs and affordability

43% of Latino voters report renting their current home or living with someone who rents, while 48% indicate they own their current residence.

Among those who rent or live with someone who rents, nearly 8 in 10 report their **rent has increased** in the last year (79%).




[Among those who rent or live with someone who rents] Has your rent increased in the last year?






Budget changes to fund health care policies

A majority of Latino voters support measures directed at funding comprehensive health care policies that benefit all Nevada residents.

79% support additional taxes or reallocating current funds for health care measures.

- 1 in 4 would support either of the two proposed funding changes
- 15% would support additional taxes
- 26% would support budget reallocation but not an increase in taxes





85% of Latino voters support additional taxes or reallocating current funds for other health care measures.

- 2 in 5 would support either of the two proposed funding changes
- 16% would support additional taxes
- 28% would support budget reallocation but not an increase in taxes



What we learned

- 1. For Latinos today **costs** continue to be top of mind concerns and they want to hear solutions
 - Cost of living, housing affordability, and health care costs
- 2. Housing is the highest cost in every voter's daily life and they like specific proposals that they connect with and see impacting their life and their pocketbook
- 3. Nevada Latinos are still very much an immigrant-friendly community, concern over the Southern border does NOT translate into opposition to immigrants already living and working in Nevada. Latino voters agree with more protections for immigrant families in Nevada.
- 4. Lowering prescription drug prices for Nevada ranked highest in intensity above 70% *very important* across nearly ALL segments.
- 5. 54% of Latino voters in Nevada report speaking Spanish at home with family or friends daily. Expanding access to Spanish materials is a crucial service that has economic impacts
